



COOPERATION AGREEMENT
BETWEEN THE
UNIVERSITY OF ALGARVE - PORTUGAL
AND
UNIVERSIDAD DE TALCA - CHILE

The University of Algarve, succinctly hereinafter referred by UALG, established at *Campus* of Penha, in Faro, with the legal person identification number 505 387 271, represented by his Rector, Professor João Pinto Guerreiro, as the 1st Granter, And Universidad de Talca, succinctly hereinafter referred by UTalca, established at Calle 2 Norte 685, Talca, represented by his Rector . Professor, Dr. Álvaro Rojas Marín as the 2nd Granter.

The Grantors agreed upon, the present Cooperation Agreement and under the following terms:

1st Article

Purposes

The primary purpose of this Cooperation Agreement is the promotion of initiatives that promote the scientific and technical cooperation between UALG and UTalca

2nd Article

Ambit

The cooperation will be established for the interests for both institutions, namely concerning the:

- a) Exchange of faculty members, undergraduate and postgraduate students;
- b) Scientific and technical cooperation, namely in laboratorial terms in areas with appropriate valences;
- c) Cooperation in some education areas and in the promotion of specific actions of training, including their joint conferences, discussions, seminars and similar activities.



3rd Article

Functioning

- 1 – The implementation of this Cooperation Agreement will be defined case by case, through the celebration of Specific Cooperation Agreements or through the simple correspondence between the responsible of both institutions.
- 2 – The Rector of UALG and UTalca could, whenever they wish, nominate representatives and give them the powers of signature and execution of Agreements that are celebrated under this agreement.
- 3 – These agreements will take into account the specificities of each action that must be properly framed, in particular as regards the definition of objectives, the methodologies to be applied, the means to provide and the financial resources involved.

4th Article

Obligation of the parties

In order to establish the intended cooperation correctly, any party, after consultation, undertakes to make available to the other the means necessary to implement the agreed measures, respecting the rules between them and without prejudice to its normal operation.

5th Article

Management Committee

- 1 – The coordination of the activities under this Agreement shall be the responsibility of a Management Committee, constituted by a representative of each Granter, designed in a term of 30 days after signing it.
- 2 – The Committee administers the Agreement, by promoting the celebration of specific agreements, managing globally his implementation and informing regularly the parties about the activities in operation.



6th Article
Publications

All publications resulting from actions taken under this Agreement shall be properly referenced concerning its authorship and participating institutions.

7th Article
Duration of the Agreement

- 1 – This agreement will remain for a period of time indeterminate coming into force upon his signature, and may be reviewed at any time that parties consider appropriate.
- 2 – The agreement may be rescinded at any time, by agreement of both parties, or terminated by either party, by registered letter sent to the other party with at least 30 days.
- 3 - In case of rescission or terminus of this agreement, both parties are obliged to fulfil the obligations under this agreement and it will not affect activities that are currently being developed.


8th Article


